



## CAT ADOPTION AGREEMENT

I, (We), \_\_\_\_\_ the undersigned Adopter, (hereinafter referred to as ADOPTER), agree to all the terms and conditions set forth within the pages of this adoption agreement as provided by the ORPHAN Network, (hereinafter referred to as ORPHAN), and confirm that the information provided in the associated Application for Adoption is complete and correct to the best of my (our) knowledge. We agree to these terms and provide an adoption fee of \$75.00 in order to adopt the pet,

I, (We), understand that non-compliance with the terms and conditions of this agreement, at the sole discretion of ORPHAN, or misstatement of facts on the Application for Adoption grants ORPHAN the right to reclaim PET with no refund or recourse due ADOPTER.

This agreement will be in effect as of \_\_\_/\_\_\_/\_\_\_ and will continue until the death of PET, repossession of PET by ORPHAN, or return of PET to ORPHAN (for any reason) by ADOPTER. All litigation, arbitration or other legal matters regarding this adoption are to be resolved under the appropriate legal office of the state of Ohio and in the state of Ohio. ADOPTER further agrees that should any such legal actions be resolved in favor of ORPHAN, ADOPTER will reimburse ORPHAN for attorney's fees and expenses incurred as a result of the dispute.

### RELEASE of LIABILITY and INDEMNIFICATION

In consideration of allowing me/us to adopt PET, I/We promise and agree to be solely responsible for this animal and to indemnify and hold harmless ORPHAN, affiliated organizations, volunteers and representatives from all claims of liability for the conduct of this PET on or after the date of this agreement. The undersigned(s) further agrees and intends that this RELEASE OF LIABILITY AND INDEMNIFICATION shall apply to all known, unknown, and unanticipated damages resulting from my/our adoption, ownership or control of such animal.

We have read and hereby agree to abide by all the TERM AND CONDITIONS of this ADOPTION AGREEMENT concerning the adoption of PET. THIS IS A BINDING CONTRACT, ENFORCEABLE BY CIVIL LAW.

## Terms and Conditions of Adoption Agreement

- (1) To treat PET as an indoor family pet, with affection and kindness and not subject Pet to abuse, cruelty or neglect as defined by ORPHAN at any time.
- (2) To give PET at least 3 to 4 weeks after adoption to adjust to new surroundings, in consideration of the fact that it takes this time period for an animal to adjust to a new environment, and for both PET and ADOPTER to adjust to each other.
- (3) To return PET only to ORPHAN if unable to keep.
- (4) To keep PET indoors at all times, except when being transported as covered in item #12.
- (5) To notify ORPHAN immediately by telephone if PET is lost or stolen and to make every effort to locate the PET including placing advertisements in local newspapers, notifying local law enforcement officials and regularly checking local animal shelters and pounds for a period of two weeks.
- (6) To never take PET to an animal shelter, pound or humane society for the purpose of releasing ownership to such organization.
- (7) To never allow to be used or to use PET in animal research.
- (8) To never allow to be used or to use PET for fighting, fight training, baiting or related activities whether legal or illegal in the state of residence.
- (9) To provide regular veterinary care, including annual checkups; vaccinations as needed; parasite checks, prevention and treatment; and dental care.
- (10) To provide proper food, shelter, fresh water, adequate companionship at all times, and to keep PET on a leash or in a crate when not on ADOPTER's property.
- (11) To feed and maintain PET on a premium, meat and vegetable based cat food at all times.
- (12) To never transport PET without proper restraint designed specifically for this type of pet. To never leave PET alone in a parked car, nor in any way to endanger the cat in similar fashion.
- (13) To notify ORPHAN within 5 days if I (we) move and to provide new address and phone numbers for work and home.
- (14) To notify ORPHAN within 5 days of the death of PET.
- (15) To allow ORPHAN representatives to periodically check on PET to assure compliance with items #1 through #14 of this agreement.
